NOTICE OF RACE

(19 June 2004)

Regatta Venue

The Crystal Lake Yacht Club will host the 46th Annual Championship Regatta on September 9th, 10th and 11th, 2003 on Crystal Lake in Frankfort, MI (see map).

Organizing Authority

The National Class E Scow Association in cooperation with the Crystal Lake Yacht Club.

Rules

The Regatta will be governed by The Racing Rules of Sailing.

Advertising Category

This Regatta is designated a Category A event in accordance with RRS Appendix G.

Eligibility

The Regatta is open to all yachts which meet the rules of NCESA whose helmsperson is a Regular Member of NCESA, whose crew are either Associate or Regular Members of NCESA, and whose sails and equipment comply with the Scantlings and By-laws of NCESA.

Entries

Entries will be made on the official entry form (enclosed). The form must be returned, postmarked no later than August 20, 2004 to receive the pre-registration discount.

Registration

Registration will be held at Crystal Lake YC, 3491 Pilgrim Hwy, Frankfort MI on Wednesday, September 8rd, **3:00 PM – 9:00 PM** (see schedule of events).

Measuring and Weighing

Boats that bear a silver certified lead added label and/or white tamper-proof sticker will not have to be reweighed at the regatta site. Sails must contain a manufacturer's serial number (or measurer's serial number) and an NCESA Royalty Tag. Sails may be measured at the regatta site.

Equipment

VHF Radio will be used by the RC to communicate with competitors. Floatation panels may be required during racing at the discretion of the PRO.

Awards

Awards will be those specified in By-Laws Article IX. Top Ten Overall, Top 3 in Red Fleet, Top Rookie and Top Master, sailors have the option of participating in the Red Fleet at registration.



Schedule of Races

The warning signal for the first race is scheduled for 10:00 AM on Thursday, September 9. A maximum of six races will be sailed in the series. There will be no more than three races per day and no more than two back-to-back.

Competitor's Briefing

The Competitor's Briefing will be held at 8:30 AM on Thursday, September 9th, at CLYC (see Schedule of Events).

Scoring

Scoring will be according to the Low Point scoring system as outlined in Rule A2 of Appendix A of the Racing Rules of Sailing. If six races are completed, each yacht will have its worst score excluded from its total.

Sailing instructions will be made available at registration.
